

Statement of Compliance for Food Use

We declare that films provided by Film and Foil Solutions Ltd for packaging applications used in normal and foreseeable conditions of use are suitable for direct contact with foodstuffs, being in conformity with:

Regulation (EC) **No 1935/2004** – Article 3, 11(5), 15 and 17 of the European Parliament and of the council of October 27 October 2004 on materials and articles intended to come into contact with food.

Commission Regulation (EC) No. **2023/2006** of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food.

Commission Regulation (EU) No. **10/2011** of 14 January 2011 including and up to 2023/1442/EU (and also all subsequent amendments) on plastic materials and articles intended to come into contact with food.

Product description:

Plain or printed film supplied in reel format as single wound sheet, folded sheet, Macro punched, unperforated or micro-perforated. Boxed product as reel, bag or pouched.

Polypropylene (OPP and BOPP), Matt, Gloss or Silk OPP Thermal Lamination Film, Polyester (PET).

Specification agreement is based on both the customer's requirements and the final product use.

The films provided by Film and Foil Solutions Ltd have been certified by our suppliers as complying with the legislation and recommendation of each EU member state and are exclusively manufactured from monomers and other starting substances which are listed in 1282/2011/CE.

The Global Migration limit (GML)

Laboratory analysis of the film, executed by an accredited institute according to the testing methods and conditions as laid down in the European Directives 10/2011 and subsequent amendments, has confirmed that the overall migration for all films supplied is lower than 10 mg / dm^2 .
